Economic Injury Disaster Loan Assistance

Small business owners in all U.S. states, Washington D.C., and territories are currently eligible to apply for a long-term low-interest loan due to Coronavirus (COVID-19).

The SBA's Economic Injury Disaster Loan (EIDL) program provides small businesses and most private non-profit organizations with working capital loans of up to \$2 million that can provide vital economic support to help overcome the temporary loss of revenue they are experiencing.

***SBDC note: the SBA will determine amount of loan based on your projected expenses for six months according to last update.**
