

**RESOLUTION R2020-06**

**A RESOLUTION OF THE CITY OF WEATHERFORD, TEXAS, CALLING A SPECIAL ELECTION FOR SATURDAY, MAY 2, 2020; ESTABLISHING PROCEDURES FOR THE ELECTION; AUTHORIZING THE MAYOR TO EXECUTE THE NOTICE OF ELECTION; AND AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH THE PARKER COUNTY ELECTIONS ADMINISTRATOR FOR THE ADMINISTRATION OF THE CITY OFFICER SPECIAL ELECTION FOR CITY COUNCIL PLACE NUMBER 3.**

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WEATHERFORD, TEXAS, THAT:**

**SECTION 1.**

**SPECIAL ELECTION CALLED/ORDERED**

That the City Council orders a Special Election for the purpose of electing a City Officer for City of Weatherford City Council Place Number 3 and that the election shall be conducted according to the laws of the State of Texas, and shall be held on Saturday, May 2, 2020 from 7:00 a.m. to 7:00 p.m.

**SECTION 2.**

**NOTICE OF SPECIAL ELECTION**

A Special Election is to be held on May 2, 2020 for the purpose of electing a City Officer for the City of Weatherford City Council Place Number 3.

Early voting by personal appearance will be conducted each weekday at the Parker County Elections Administrator’s Office, Parker County Courthouse Annex, 1112 Santa Fe Drive, Weatherford, Texas, between the hours of 8:00 a.m. and 5:00 p.m. beginning on April 20, 2020 and ending April 28, 2020.


**SECTION 6.
